With first hand knowledge of the daily struggle families with children of different abilities face, Jenn sought to create a day that celebrates their many talents and abilities, a day of inclusion that shows the world who they really are, that their disability doesn't define them. Seeing that the special needs community is often left out of events, Jenn created the Talent Showcase as a way to shine the spotlight on the incredible pool of talented individuals we have in Niagara. To help advocate and create a day just for them free of judgement, bullying, staring eyes and whispers.

What is the event:

This is day of inclusion for persons of all abilities and ages to showcase their talents in a safe, family friendly environment. The event is free to participant, free to attend and every effort is made to make the participants feel like rock stars!....Not only do participants get their moment on stage to perform or display their art/crafts but they will also receive red carpet treatment with a photo shoot and a special thank you gift for sharing their gifts with us!

Vendors: 10 x 10 spots are available to vendors of all kinds. Vendors must provide their own tent/table/ chairs and are responsible for their own set up and tear down. Table must be manned at all times and vendors are responsible for collecting any monies. All vendors are required to donate a item for our raffle table. Fee to participate is \$35

Date/Time: Sunday Sept 22, 12:00pm-4:00pm

The Venue: Taps Brewhouse, 4680 Queen Street, Niagara Falls

Facilities: Wheelchair accessible washrooms available inside Taps and porta potties outdoors.

Layout: The event is held outdoors in the parking lot.

Set Up and Tear Down: Setup begins at 10am and no vendor may tear down prior to 4pm

Notice of Acceptance: Approved vendors will be contacted by email

Volunteers and Mascots: Volunteers and mascots are welcomed! If your organization is willing to send volunteers in addition to those manning your space, the \$35 fee will be waived. A volunteer t-shirt will be provided. Mascot for your organization are welcome to attend but must be accompanied by a handler. Change rooms available on site. All volunteers and mascots will be required to sign a liability waiver and media release.
